Veterinarians and VPPs can advance in their careers and gain specific skills according to the OF's planned route. The framework creates an atmosphere supporting ongoing education and career advancement by clarifying roles.
- Fulfilling New Demands
A proactive staff is required due to the changing requirements in animal healthcare and technological improvements. The OF determines the abilities and new skills needed to tackle issues, including food safety, zoonotic illnesses, and cutting-edge diagnostic technologies.
- Inclusion of Veterinary Paraprofessionals (VPPs)
VPPs are essential in helping veterinarians, particularly in underserved and rural regions. The framework closes gaps in service accessibility and raises the bar for animal care by establishing explicit training paths and policies to improve their skills.
